The above referenced case was/is eligible for discharge via set-off against the pre-paid Private Economic Reform and Stimulus Program, **P.E.R.S.**, or **P.E.R.S. Program**, established and funded through the ***National Banking Association account No. 06-50913806***, Columbus, Ohio, activated on May 21, 2009 by the Federal Reserve Banking System, Atlanta & Cleveland, as authorized by the Department of the U.S. Treasury.

It has been established, in fact, that the Federal Reserve Bank(s) and/or the corporate UNITED STATES are blocking discharge of the debt and impairing my right of redemption of the property, thereby causing loss and injury, a perpetual tort against Claimant and family, jointly and severally. ***Claimant's private rights/liberties are being unlawfully restricted by the Respondent causing loss and injury.***

Foreclosure Decree or Order in the above referenced action has been accepted, without objection or dispute, endorsed to the order of John (Jack) E. Potter, and annexed hereto and made a part hereof, and presented to Respondent in the *Nature of a Demand* for immediate settlement of the account.

Your failure to settle the account within twenty-one (21) days, or provide me, via Certified Mail, with evidence in affidavit form, signed, sworn to and notarized, including any/all documentary evidence that this claim is NOT eligible for discharge, shall constitute a commercial dishonor, establishing the evidence of your operation in equity in bad faith and with unclean hands.

Your Dishonor shall constitute your consent and agreement to an attachment of and claim against all equity claims in the name of and/or under

the control of the USPS, the organic post office for the united states of America and/or John E. Potter in his professional and private capacity, jointly and severally, for immediate liquidation for the remedy of the Principle(s).

This Maritime Contract is a **self executing claim**, valid upon your dishonor, [twenty-one (21) days], in the sum certain stated above. The Registered Mail/Contract number above, shall constitute the identification number/ securities indentifier number of the **Registered Claim** and shall constitute a Registered Attachment/Lien and a charge against Respondent to be filed with the Universal Postal Union for immediate remedy.
